



## CFLI AFFILIATE MEMBERSHIP PROGRAM

CFLI's Affiliate Membership Program invites individuals interested in increasing the awareness of Collaborative Family Law in South Florida though not eligible for full membership. Affiliate Members can be:

- lawyers that practice in areas outside of family law, such as trust and estates law, criminal law, real estate law, or immigration law;

- vendor representatives providing services to the family law community, including court reporters, payroll service providers, or public relations professionals, etc.

Affiliate Members must complete a free half-day educational program on Collaborative Family Law within six months of becoming an Affiliate Member in order to maintain the benefits of Affiliate Membership. The program will provide an overview of the Collaborative Family Law Process and offer an opportunity to participate in a question and answer forum about Collaborative Family Law.
